CONTRACT AGREEMENT

THIS AGREEMENT made this ______ between PHILIPPINE CARABAO CENTER of the Philippines (hereinafter called "the Entity") of the one part and JTIM ENTERPRISES of Mission Hills, San Roque, Antipolo City, Rizal (hereinafter called "the Supplier") of the other part;
