CONTRACT AGREEMENT

THIS AGREEMENT made this 30th June 2021 between PHILIPPINE CARABAO CENTER of the Philippines (hereinafter called "the Entity") of the one part and AHP FARM SOLUTIONS of Zone 6, Talavera, Nueva Ecija (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly (GAA 2021) SUPPLY AND DELIVERY OF BUFFALO FEED CONCENTRATES (4,833 BAGS) 1 LOT and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Million Four Hundred Sixty Thousand Three Hundred Thirty-Five Pesos (P 5,460,335.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

- In consideration for the sum of Five Million Four Hundred Sixty Thousand Three Hundred Thirty-Five Pesos (P 5,460,335.00) or such other sums as may be ascertained, AHP FARM SOLUTIONS agrees to supply and deliver the buffalo feed concentrates in accordance with his/her/its Bid.
- 4. The PHILIPPINE CARABAO CENTER agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
