- 3. In consideration for the sum of Seventy-Six Thousand Fifty-Eight Pesos (P 76,058.00) or such other sums as may be ascertained, NOVEAULAB ASIA CORPORATION agrees to supply and deliver the laboratory chemicals and supplies in accordance with his/her/its Bid.
- 4. The **PHILIPPINE CARABAO CENTER** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
