between PHILIPPINE CARABAO THIS AGREEMENT made this CENTER of the Philippines (hereinafter called "the Entity") of the one part and LSERV CORPORATION of 12F& 21F Petron Mega Plaza, 358 Sen. Gil Puyat Avenue, Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly (EPA 2022) JANITORIAL MAINTENANCE AND OTHER RELATED SERVICES (59 PERSONNEL) (JANUARY 1-DECEMBER 31, 2022) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Eleven Million Eight Hundred Ninety-Seven Thousand Four Hundred Fifty-Eight Pesos & 56/100 (P 11,897,458.56) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
