CONTRACT AGREEMENT

THIS AGREEMENT made this	JAN 0 5 2022	between PHILIPPINE CARABAO
CENTER of the Philippines (hereinaft	er called "the Entity")	of the one part and AHP FARM
SOLUTIONS of Zone 6, Talavera, Nueva l	Ecija (hereinafter callec	I "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly (EPA 2022) SUPPLY AND DELIVERY OF BUFFALO FEED CONCENTRATES (1 LOT) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Million Seven Hundred Fifty-Five Thousand Seven Hundred Forty-Five Pesos (P 5,755,745.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - d) Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice 19
