

RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (107,640 PACKS) FOR DSWD REGION 4A CAVITE

WHEREAS, the Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency/project upon favorable recommendation of the Bids and Awards Committee (BAC).



WHEREAS, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the supplier, **GENERAL TRIAS DAIRY RAISERS MULTI-PURPOSE COOPERATIVE** has submitted the single calculated quotation for the **SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (107,640 PACKS) FOR DSWD REGION 4A CAVITE**;




